
## Abbott's NPC journey and the adoption of GS1 Standards

## The NPC & GDSN the need to act locally, while thinking globally

- National initiative driven by NeHTA
- Single catalogue
- Multiple divisions; multiple business platforms
- Loaded all divisions operating in Australia (with one exception) in July 2007
- Loaded remaining divisions including acquisitions
- Currently 4,000 plus GTINS
- Data for most divisions loaded via SAP (system-tosystem auto data upload via AS2 connection)
- One division using Browser template
- Implementing Innovit MDM iiCE and then separating catalogue

#### Abbott's GSSO:

Establish and manage the serialization process across Abbott

Establish corporate standards for hardware & software

Develop corporate policies to document and control processes

In preparation for serialization, convert to GS1 GTIN product numbering schema

Adopt complementary business schema – GLN, GDSN

Centralize data management – Product, Customer, Serial Numbers

#### HOW... to start:


Organise, harmonise and clean data, streamline for mission
