- Simple and easy to use worldwide standard for GTIN Allocation in Healthcare
- Schedules & Milestones
 - Team formed December 2005 ✓
 - March 2006 (Rome) concept and complexities reached ✓
 - June 2006 (Minneapolis) finalise concept and table of content, difficult issues advanced. ✓
 - **September 2006 (Paris) HUG to finalise**



3) Final GTIN Rules – Sept 06

- Feedback comments received from over 20 sources
- +/- 200 comments tabled for discussion
- Majority of comments closed via direct and teleconference correspondence.
- Final update based upon yesterday's clarifications.
- Leadership team to provide HUG GTIN Allocation Rules for Healthcare (**October 06**):

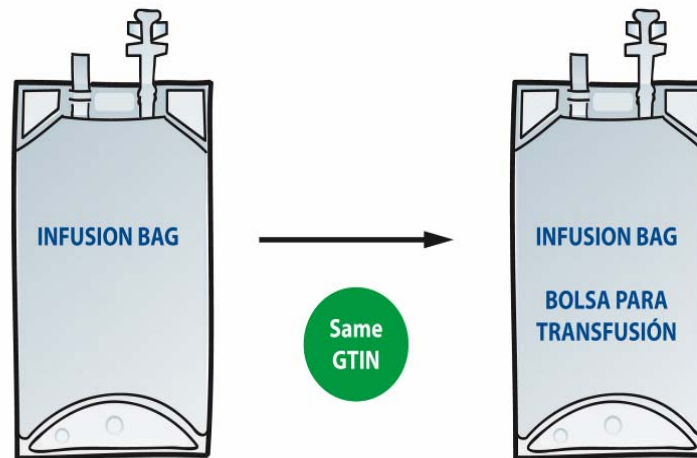
