How GS1 Standards enable efficiency, visibility, safety & collaboration



"St. James's Hospital's fundamental purpose is the delivery of health treatment, care and diagnosis as well as health promotion and preventative services"



#### St James's Hospital - Overview



- St James's is the largest adult hospital in Ireland (1,000 beds)
- SJH is also an Academic teaching hospital providing clinical services at catchment, regional, supra regional and national level
- SJH hosts the National Centre for the treatment of haemophilia patients.
- SJH has already worked with GS1:
  - NCHCD Track and trace of blood product for haemophilia patients
  - HSE National Sterile Instrument tracking solution

# St James's Hospital Background to request Oct 2011 – First email



- "The organisation has been using the National Supplies
   Vocabulary (NSV) since 1995 as both a coding system and
   standardised hierarchical nomenclature".
- "We migrated our business process to the SAP ERP system in 2004".
- "We started using barcodes (code 128) in 2005 in conjunction with full SAP GUI wireless devices".
- "The Hospital is actively considering a move to GS1 (products and services only) and therefore we have a number of questions.."



## How NPC could help? The Australian experience

The NPC enables synchronisation of product and pricing data for accuracy for both electronic procurement and product usage



The proposed National Product Catalogue solution for healthcare is

- a single repository of
- all product specifications
- procured by the Irish Healthcare sector
- and is replicable across industry sectors





### **Proof of Concept** Definition





#### SJH strategic objectives



- Embrace Global Standards to
  - Reduce medical errors through GS1 based e-prescribing
  - Facilitate EPR treatment documentation.
  - Unique device identification
  - Leverage experience in Haemophilia and HSSU
  - Increase efficiencies in Supply Chain through the implementation and use of global standards
  - Capture additional information such as lot number, batch number and expiry date
  - Make a substantial contribution to a single national repository of master data for products and services



#### **Envisaged Solution**




► Alignment and Synchronisation of accurate product master data between SJH and its supplier base using GS1, coupled with the deployment of secure, standard EDI messaging necessary to generate the required business transactions electronically.

### Master Data (NPC) and Electronic messaging (EDI) based on GS1 Standards

#### **POC Pilot Scope**



#### The pilot will include the following key processes:

- Master Data Synchronisation via the GDSN (Global Data Synchronisation Network)
- Deployment of the EDI messaging suite Order,
   Advanced Shipping Notice, Receipt Advice, Invoice
- Labelling of consignments (carton/pallet) with GS1 identifiers and barcode symbologies
- AIDC (automatic identification and data capture) at SJH to record receipt of goods and to complete the 3 way matching process to enable prompt payment.

### POC Pilot Scope Parameters





- 3 Suppliers (J&J, Medtronic, Synthes)
  - Sending Product master data for 5 GTINs via GDSN
  - Exchanging EDI messages for Order, Advanced Shipping Notice, Receipt Advice and Invoice using XML 3.0
  - Categories special focus on orthopaedics, implantables, cardiology and radiology (consignment not included for POC)
  - Coding GS1 coding and standards, NSV will coexist and will be maintained until full move to GS1 coding is possible



# POC Pilot Scope Ireland Outline of process steps



#### -NPC

- Supplier uploads data via GDSN (Global Data Synchronisation Network)
- SJH receives data into PIM (Product Information Manager) and pulls into their internal ERP (backend system, SAP)

#### -EDI

- PO (Purchase Order) is generated by SJH
- Supplier sends back an ASN (Advanced Shipping Notice)
- SJH acknowledges receipt with a RAN (Receiving Advice Notice)
- Supplier sends the Invoice





- Finding the Champions
- Start small and keep it simple and in scope
- Patience
- Education
- Development work The first few steps are the hardest and take the most time
- GS1 Standards are the key enabler
